NOTIFICATION

In exercise of the powers conferred by rule 8 of the Rajasthan Chief Electrical Inspector and Electrical Inspectors (Powers and Functions) Rules, 2016, the State Government, with immediate effect, hereby makes the following amendments in this department's notification number F.22(20)Energy/94 dated 22.09.2016, namely:-

AMENDMENTS

In the said notification,-

- (i) in the schedule of fees, the existing heading SCALE "B" and entries relating thereto shall be substituted with the following, namely:-

and (ii) the existing note (6) shall be substituted by the following, namely:-

“(6) The fees for inspection and testing of installations carried out by Electrical Inspectors or any other officer appointed to assist him, shall be paid by the owner or his agent through online mode of payment or through Demand Draft drawn in favour of Senior Electrical Inspector, F 101, Panchsheel Marg, Near Bagadia Bhawan, C Scheme, Jaipur, Rajasthan, Pin-302001. The copy of online receipt of payment shall be sent to the Electrical Inspector or Assistant Electrical Inspector.”
