Order

As per the provisions of Notification No. F/FA&CAO/RWSSMB/Mission/2014-2015/245-262, dated 5th November 2015, Notification No. F/FA&CAO/RWSSMB/Mission/2014-2015/751-768, dated 6th June 2016 and Order No. F/FA&CAO/RWSSMB/Mission/2014-2015/18886-902 dated 31st March 2017, the Water Tariff and all other charges on all categories of consumers are to be revised every year with respect to tariff applicable on preceding year. In compliance of above, the Water Tariff and all other charges hereby revised multiplying by a factor 1.1 with respect to tariff applicable on preceding year with effect from 1st April 2018 payable in May 2018 as specified below:
