
Process Flow: Subscribing Services

- Citizen will be login through SSO (Single Sign On).
- In the citizen Apps select the Urban Service
 Application and click on it. It will redirect to Urban
 Services Portal.
- By Default citizen Dashboard will be visible.
- Click on the Citizen Services link for availing the services from the side panel menu.
- Services list will be visible to the citizen user.
- Against each of the service subscribe button is there click on subscribe button for availing the service.


- After click on Subscribe button citizen will be redirected to the subscription form where citizen will be subscribing for the service. In that Name, validity, fees for the services are being described.

- Service will be availed.


- If the subscription is free then citizen can avail the services directly.

 Name transfer application, the property which is approved and id number is generated that only property number can be searched by the shown filter criteria.






