Office Order

Implementation of online module for submission of authorization applications under Construction & Demolition Waste Management Rules, 2016

Authorization for storage, processing or recycling facilities for construction and demolition waste is required to be obtained from Rajasthan State Pollution Control Board under the provisions of Construction & Demolition Waste Management Rules, 2016.

The Rajasthan State Pollution Control Board has developed and operationalised the module for online submission of the applications for authorization under Construction & Demolition Waste Management Rules, 2016 along with requisite documents.

It is directed that:-

1. Henceforth, all the applications for authorization under Construction & Demolition Waste Management Rules, 2016 shall be submitted through online module only and no offline application for authorization under these Rules shall be accepted.
2. Project proponents will ensure submission of requisite information and attachment/uploading of necessary documents before final submission of online applications.
3. Fee of Rs. 25,000 (In words Rupees Twenty Five Thousand only) shall be paid by the project proponent with authorization application under Construction & Demolition Waste Management Rules, 2016 in addition to Rs. 1000/- (In words Rupees One Thousand only) for prescreening..
4. All applications for the renewal of authorization under Construction & Demolition Waste Management Rules, 2016 shall be made online before ninety days of its expiry mandatorily.
5. The application for authorization shall be accompanied with following documents:-
 - a. Copy of consent to operate under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981.
 - b. Affidavit in prescribed format.
6. The application for authorization shall be disposed by the State Board within 90 days of the making an application in this behalf complete in all respect.
