CIRCULAR

In exercise of the powers conferred by section 21 of The Rajasthan Enterprises Single Window Enabling and Clearance Act, 2011(Act No. 7 of 2011), the State Government has notified the Rajasthan Enterprises Single Window Enabling and Clearance (Amendment) Rules, 2016 on May 24, 2016. The new Rules have facilitated online application, payments, status tracking, approvals and issuance of the certificates. The rule-3 of Rules, 2016 mandates online submission of application for approvals under Single Window System.

A single window application has been developed by DoIT&C for fully online Single Window System facilitating online application, payments, status tracking, approvals and issuance of the certificates through Common Application Form (CAF). The Online Single Window System allows the investor to select more than one service of different departments and apply through Common Application Form (CAF). In addition to this CAF has been developed to facilitate applicant, submission of hardcopy of application/ registration form is hereby dispensed for services rendered under Advanced Single Window notified by the State Government.

All departments are requested to encourage citizens/investors in this regards so as to maximise the usage of CAF and online Advanced Single Window Clearance System facility.

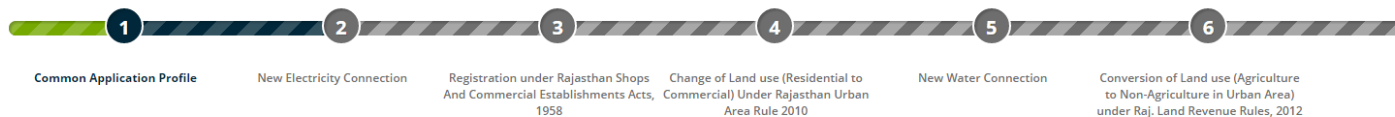

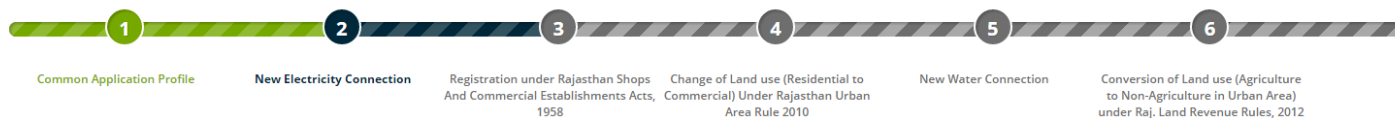
