## **FACTORIES & BOILERS INSPECTION DEPARTMENT** NOTIFICATION

Jaipur, March 14, 2018

G.S.R.134 .- Whereas the draft of the Rajasthan Factories (Amendment) Rules, 2018 were published as required under section 112 of the Factories Act 1948 (Central Act No. 63 of 1948) vide notification of the Factories & Boilers Inspection Department, No. F-3 (1) legal/F&B/2017/50 dated 24-01-2018, Published in the Rajasthan Rajpatra Extraordinary, Part-3 (kh) dated 25-01-2018 inviting objections and suggestions from all persons likely to be affected thereby, before expiry of the period of forty five days from the date on which copies of the Gazette containing the said notification were made available to the public.

And whereas, copies of the Gazette in which the said notification was published were made available to the public on the 25.01.2018.

And whereas, no objections or suggestions were received form the public in respect of the said Draft Rules.

Now, therefore, in exercise of the powers conferred by section 112 of the Factories Act, 1948 (Central Act No. 63 of 1948), the State Government hereby makes the following rules further to amend the Rajasthan Factories Rules, 1951, namely:-

#### RULES

1. Short title and commencement.- (1) These rules may be called the Rajasthan Factories (Amendment) Rules, 2018.

- (2) They shall come into force with effect form 01-04-2018.
- 2. Amendment of rule 4.- The existing Schedule-A and Schedule-B given rule 4 of the Rajasthan Factories Rules, 1951, shall be substituted by the following, namely:-

(b) The fees for grant of original licence shall be 50% more than the fees payable for renewal of licence.

#### EXPLANATION:

- 1. Where an electricity generating factory includes a transmitting or converting station or plant meant for receiving, transforming, converting or transmitting or electric power supplied from a source outside the generating station and which is not meant for transforming, converting or transmitting of power generated in the generating station itself, the fees payable shall be the sum of fees payable by the generating, transforming (including converting) and transmitting stations respectively calculated separately as if they were separate factories.
- 2. If any generating, transforming, converting or transmitting station is situated in a factory for which licence fees has been prescribed in Schedule-B and if it is meant for supplying power only to the said factory exclusively and is a part of the said factory the fees will be payable in accordance with Schedule-A and not Schedule-B and on the basis of the total rated horse power installed in the factory."
